Short term: Acetaminophen has been associated with cases of acute liver failure resulting in

liver transplant and death. Most of the cases of liver injury are associated with the use of acetaminophen at doses that exceed 4000 milligrams per day, and

often involve more than one acetaminophen containing product.

Hydrocodone may cause lightheadedness, sedation, dizziness, pinpoint pupils, nausea and vomiting. Other side effects include constipation, rash and itching.

Long term: May be habit forming.

Known Clinical Effects: Therapeutic use of this substance has resulted in liver failure, serious skin

reactions such as acute generalized exanthematous pustulosis, Stevens-

Johnson syndrome and toxic epidermal necrolysis.

Ingestion of this material may cause effects similar to those seen in clinical use including dry mouth, drowsiness, headache, dizziness, nausea, vomiting, weakness, anxiety, blurred vision and dilated pupils. Cases of overdosage may also lead to respiratory depression, hypotension, coma, convulsions, cardiac
